Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • Sellwood Consulting LLC does not share information with Nonaffiliates for marketing purposes.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Sellwood Consulting LLC does not engage in joint marketing.
